MASTER'S ANNUAL ADDRESS

Worthy National Representative Cindy Greer, Officers, Delegates and Members of the Maine State Grange,

It is an honor to present the 2023 Maine State Grange Annual Address at the start of our 150° anniversary year as a State Grange. We can only imagine what effort it took for that first group of people to meet together, just the challenge of getting there, what dedication. We are here today because we have a similar dedication to the principles of our organization and the heartfelt desire to continue to be helpful and keep it going. We as an organization, have accomplished great things in the 150 years of our existence and the opportunity is ours to continue that tradition for a very long time to come.

Jim Owens and I represented Maine last November as the delegates at the National Grange in Sparks, Nevada participating in all work and activities. I was assigned to the Agriculture committee and Jim assigned to Grange Law. We did our advance work by zoom before the convention on the Present Policy, Policy Statements, and reviewed Resolutions.

Richard and I will be the delegates at the 2023 National Grange Convention which will be hosted by the Northeast Region held in Niagara Falls, New York November 12th – 19th. The 7th Degree will be conferred on Saturday November 18. This region hosts every five years. Richard has been assigned to the Labor, Judiciary, & Transportation Committee and I have been assigned to Citizenship & Taxation. Again this year, we will do updates from home by zoom to Present Policy, Policy Statements and review Resolutions this saves considerable time before the session opens. The 7 regional states have a good handle on the plans for that event. Volunteers will be needed for the convention, for different activities, please help out if you can. We still have 2023 National Convention T-shirts here for sale.

I work at the office in Augusta and continue to do a lot of Grange work from home and camp. I have communicated directly with the Subordinate & Pomona Masters/Presidents answering questions, calls & emails, creating, printing & sending assorted information, if one person asks a question I share the answer and info with all. I have sent letters to the Granges, State Officers, Deputies and Directors and others on a variety of subjects, and written a monthly article for the builetin.

Richard and Fattended 11 informational and instructional meetings, all over the state, answering questions and providing copies of materials to everyone present. Sharon also participated in most meeting, presenting information to the Secretaries. I have continued to update the paperwork describing ritual floor work and 'how-to' information in more detail and making it easier to understand. I hosted Instructions for Deputies, Officers, and Directors during the year, gaining a lot of input and ideas from those attending. I traveled to closure or consolidation meetings when required or was invited, presented certificates, signed paperwork for deeds and contracts for the sales of buildings, etc. There are 6 halls available for sale.

In addition to the updating the instructional guidelines, roster, state session & budget. and other items I work on, I have worked on getting a new database completed. I typed in all the information for our 82 Granges, 2,359 names, addresses and other information into a more user friendly format that can be accessed without internet. The basic information has been compiled, and copies sent to the Grange Secretaries for corrections, additions and deletions. Yes, I can hear the grumbles but it needed to be done, if I am spending this much time putting it. back together from older versions provided by the State Secretary, your assistance is greatly appreciated. Each of you, as an individual member can help by checking your information, is your name spelled correctly, is your address up to date, if not, then please correct whatever may be required. I am most interested in the date you joined the Grange, and the Granges you have belonged to, many of the dates or previous membership in a different Grange (because of closure or consolidation) are not listed. Some are listed as Golden Sheaf members (50 years of continuous membership) but do not list the date of joining or where. Most Granges exempt all Golden Sheaf (50 year) members from paying dues to their respective Granges and the Maine State Grange does not charge dues on any Golden Sheaf members but the Maine State Grange must still pay dues to National on them. Golden Sheaf membership attained before Jan 1, 2001, the Maine State Grange does not pay dues to National Grange on those members. Golden Sheaf membership attained after Ian 1, 2001, the Maine State Grange must pay dues to National Grange on those members.

Once again during this past year our ranks have been broken with the loss of many special members and good friends. Former State Master, Philip Arthur Herbert passed to the great Grange above in December. We have lost several prominent Deputies, and many other valuable members. Their passing was a difficult time at the Subordinate, Pomona and State levels and these strong notable Grange personalities will certainly be missed by many.

Meetings and Membership

Most of our Granges are doing well, some of these Granges are large and some are the smaller ones doing great things in their communities but we still have other Granges that are struggling. We have a few Granges that are considering consolidation or closure, they have been struggling for some time, invite them to be part of your Grange. Membership, attendance at meetings, participation and finances continue to be the biggest concerns and are vital to our organization. A strong sense of achievement and service to our communities must be developed. Community activities and involvement are important but so is the Grange Ritual. The Grange Ritual (the set pattern that we do things at each meeting) may seem outdated to some or unnecessary, but it is part of this Fraternal Organization and to be considered a **Grange, to use the term "Grange"** certain requirements must be carried out and the ritual MUST be followed. Opening the Bible, the Prayer, the Grange Salutation, and Salute to the Flag must be done at every meeting no matter what level you are working in. Some things have been modernized and simplified but the basics are still there. Let's make the effort to be part of it whether in person or by use of technology.

Many more Granges conferred the Obligation Ceremony and several successful degree days were held throughout the state at different times during the year. We had 19 Granges with Net Gains in Membership, that's almost a quarter of our Granges. However, we did not have a net gain overall this year. Maybe next time. Thank you to all who took the time to invite someone to join and to the members who organized and took part in the obligation ceremonies and degree work. I have encouraged Granges to handle degrees and installations on their own and many have reported finding this very satisfactory and easier than they thought. Now let's put the seasoned members AND new members to work with something meaningful for them to do and keep their interest involved. We enjoy going to Grange, but we need to continually work to make our meetings and activities productive and interesting. New ideas came out of necessity, we need to continue with our renewed excitement, new ideas and the positive energy can be contagious. Many public events were held, where we had a manned booth and some unmanned, an ag trade show, fairs, and other events where we publicized Grange.

Membership Director, Rick Grotton writes an excellent column for the Bulletin every month with helpful tips and suggestions, please check it out.

Internal fighting is a problem and hurtful to our Order, we are a collective group working together for the betterment of all, no one or two members should control everything that happens in the Grange. Many problems could have been prevented had our members followed the rules and procedures that we have in place, plus using some tact, common courtesy and respect for each other. Every member in every Grange has a say and a vote on what goes on, whether they agree or disagree with your opinion, each is entitled to that vote. Respectful discussions must take place in the meeting where each can express their views and listen to others views. Decisions are to be made in the meeting, open in full form, with all participating not by a few in the kitchen or grocery store. Reach out to those members who haven't been to Grange for a while, what can we do to get them to return? Is it a matter of a ride, a different day of the week or consider a day meeting?

Headquarters

The Maine State Grange headquarters building in Augusta has had a tough year as you can see from the budget. The pipes froze upstairs, burst and caused damage in that bathroom and ran down into the dining room, causing lots of damage there too. It has been stripped down but not reconstructed yet. Next, the furnace in the garage end of the building finally gave up the fight, and stopped working. A new furnace had to be special ordered and built to replace the old one. In order to put in a new furnace, the chimney on that end needed to have a liner installed. While we were at it, we also had to have all the chimney tops fixed because of the crumbling bricks coming off of them. Now we have a leak in the septic pipe from the upstairs bathroom that runs through the dining room ceiling, luckily it is visible, and now needs replacement.

Sharon and Henry Morton spend a lot of time at our building, doing a whole variety of BIG jobs and extras, like letting in the plumber, electrician, furnace man, and the list goes on and on for the good of the Grange and not because they have to, or are asked to, but because they care about the Grange. Most recently they have been chasing away the vagrants and

cleaning up after them, who have taken a liking to our porches and extra eaves to get out of the rain. The police have come several times and removed people. I don't think these jobs are the Office Secretary's obligation, more a maintenance issue but she is in the office and does them. For all **the extra** things they do for the Grange and the building, thank you doesn't cover my appreciation for their efforts. THANK YOU BOTH VERY MUCH!

Committees and Departments

Our State Officers, Deputies, Committees and Departments have continued to work promoting programs and events. Many thanks to each of you that are involved. I do have to comment, getting these Officers and Directors to provide a year end report has been challenging like pulling teeth, to say the least. It needs to be sent to me as Master/President in a reasonable time, there is a deadline so we can get them printed for session. Yes, it should go to the webmaster but I need it sent to me.

Many of our current members will continue in their positions and some will change. If anyone is interested in being a deputy, committee chair or part of one of these committees let us know.

Agriculture

The Agriculture Committee under the direction of Willie Grenier, promotes agriculture with their participation in several statewide events and has met often during the year. The committee gave scholarships again this year to students going to college with agricultural pursuits. They need your help to get the word out to the schools that this program is available and certainly rely on your donations to make these scholarships possible.

Agriculture in Maine continues to have many challenges. It makes more sense than ever to purchase locally, if we do not support agriculture in the State of Maine, it will continue to disappear.

Fairs

Many Granges participated at the Agricultural Fairs with wonderful exhibits or displays. Congratulations. The building Superintendents, appreciate your efforts and need your displays to get people to come in and look around, keep up the good work. Congratulations to Marilyn Stinson for all the fair exhibits she took the time setting up on behalf of the Junior Committee.

The New England Grange Building at the Big E did very well. Thank you Mike, Judy, and Jimmy, for working in the Big-E store for the first weekend. Thankyou Mike for taking the quilt and sales items down. Thank you to all who sent items for the sales tables, they will gladly accept all that you can provide for next year.

Committee of Women's Activities

The Committee of Women's Activities under the direction of Margaret Henderson has been busy with many projects. Their donations toward Home for Little Wanderers and House in the Woods program through your kind contributions is certainly beneficial to many.

Thank you to all who sent items for the State sales tables at the yard sale and here.

Community Service

Director Christine Corliss received 10 notebooks this year and have done such outstanding work in their communities. I know that many more Granges are also doing superb community service in their towns and areas but our Granges need to publicize our helpful deeds better. Philip Arthur Herbert, former Master of the Maine State Grange, died on December 12, 2022 in Hudson, Maine at the age of 90.

Phil was born I Bangor and graduated from Old Town High School. He enlisted in the Army in 1952 and served until 1956 as a Supply Sergeant. He worked over the years at Grant's Dairy, Penobscot Shoe Company7, Owen-Illinois (Pie Plate Factory) and returned as Supervisor of Maintenance with the City of Old Town Housing Authority. After his retirement, and not wanting to be idle, Phil went to work at LaBree's Bakery as a mechanic. For years, he always provided the donuts for all to enjoy after the 6th degree.

Phil became a member of the Olt Town Grange in February 1971. He held many positions in the Subordinate Grange such as Master, Treasurer and others. On the Pomona level he served in various positions and was a past Master. He served the Maine State Grange as a subordinate Deputy for nine years, Pomona Deputy for one year and Chief Deputy for eight years. In 1997 he was elected Master of the Maine State Grange and served for two terms. Brother Steve Verrill, former Master of the Maine State Grange, says that Phil, when he served as State Mast er, was one of the most organized planners and workers that Steve had seen in that office. Phil was a 7th Degree member.

In 1996 Phil bought a piece of land and built a house on the Penobscot River in Passadumkeag doing almost all the work himself. He enjoyed working outside, planting a garden and working in his greenhouse. He enjoyed hunting, fishing, trapping, tinkering and camping and spending time with his family.

Many of you may or may not have heard of these four brave men of World War II, let me tell you of the saga of "The Four Chaplains".

On January 23, 1943, the U.S.A.T. Dorchester, and old coastal steamer quickly pressed into service as a military transport carrying 902 service men, merchant seamen, and civilian workers left New York Harbor bound for Greenland escorted by three Coast Guard cutters. Two patrolled the flanks while the third, The Tampa was 3,000 yards out front.

Most of the men were seasick and green with nausea. The weather was bitterly cold with gale-force winds. Ice was building up on the decks, blowing the Dorchester to ten knots.

Moving among them were four Army Chaplains: Lt. George L. Fox, Methodist Minister; Lt. alexander D. Goode, Jewish Rabbi; Lt. John P. Washington, Roman Catholic Priest; and Lt. Clark V. Poling, Dutch Reformed Minister. These men of God talked with and listened to the men – soothing apprehensions, offering encouragement, and sharing jokes. By their concern and their camaraderie with the men and one another, they brought solace.

On February 2, 1943, the Tampa's sonar detected the presence of a submarine; she dropped back and swept the periphery of the convoy, but failed to find the submarine's position. That evening, the Tampa returned to the patrol area up front, and the other ships followed.

The captain ordered the men to sleep in their clothing, with lifejackets close at hand. They were only 150 miles from Greenland. With daylight, there would be air cover from the American base.

It was just after midnight on February 3, 1943 when an enemy submarine fired a torpedo toward the U.S.A.T. Dorchester's aging flank. The missile exploded in the boiler room, destroying the electric supply and releasing suffocating clouds of steam and ammonia gas. Many on board died instantly; some were trapped below deck, others, jolted from their bunks, groped, and

stumbled their way to the decks of the stricken vessel. Taking on water rapidly, the ship began listing to starboard. Overcrowded lifeboats capsized; rafts drifted away before anyone could reach them. Men clung to the rails, frozen with fear, unable to let go and plunge into the dark, churning water far below.

The testimony of the survivors tells us that the sole order and the only fragment of hope I this chaos cam from the Four Chaplains, who calmly guided men to their respective boat stations. They opened a storage locker and distributed lifejackets. Then they coaxed men, frozen with fear, over the side, soon the supply of lifejackets was exhausted. Several survivors reported watching in awe as the Four Chaplains either gave away or forced upon other young men their own lifejackets.

These four men of God had given away their only means of saving themselves in order to save others. The Chaplains gathered together, and led the men around them in a prayer and a hymn. They linked their arms together as the slant of the deck became severe. And just that way, with their arms linked in brotherhood and their heads bowed in prayer, they sank beneath the waves.

It was a heroic act. It was not the only heroic act aboard the U.S.A.T. Dorchester, but it was especially significant because of the identity of these four young men: two Protestant Ministers, a Catholic Priest, and a Jewish Rabbi.

Chaplain Memories

A table is placed in back of the Altar. A white tablecloth is placed on it. Black cloth is placed in the shape of a cross to divide the table into four sections. Each section will have a neatly folded napkin, after each Memory is read, a red rose is place on each napkin.

I light this candle in memory of Chaplain George L. Fox
George L. Fox, the oldest of the four, knew all about war. Lying about his age in
1917, he enlisted in the Army as a Medical Corps Assistant. He won a Silver Star
for rescuing a wounded soldier from a battlefield filled with poison gas, The
Croix De Guerre for outstanding bravery in an artillery barrage, and the Purple
Heart for wounds. A resident of Vermont, he was a successful accountant and
family man when he heard God's call to the ministry. Fox wen back to school
and later was ordained into the Methodist Denomination. When war came, he
once again enlisted, telling his wife, "I've got to go. I know from experience

what our boys are about to face. They need me." Fox began duty on August 7, 1942, and served until that fateful morning of February 3, 1943.

I light this candle in memory of Chaplain Alexander D. Good
Alexander D. Goode was both an outstanding athlete and scholar. Following in his father's footsteps, this young man, known for his laughter and love of life, became a Rabbi. While studying for his calling, he joined the National Guard and kept up an active membership. The return of the body of the Unknown Soldier had a profound effect on Goode. He attended the ceremonies, choosing to walk the thirty miles rather than driver or take a bus, because he thought it showed more respect. Goode married his childhood sweetheart and was serving a Synagogue in York, Pennsylvania, when World War II broke out. He served on active duty from August 9, 1942 until February3, 1943

I light this candle in memory of Chaplain Clark V. Poling
Clark V Poling was the youngest of the Four Chaplains and the seventh
generation in his family to be ordained in the Dutch Reformed Church. When
war came, he was anxious to go, but not as a Chaplain. "I'm not going to hide
behind the Church in some safe office out of the firing line," he told his father.
The elder Poling replied, "Don't you know that Chaplains have the highest
mortality rate of all? As a Chaplain you'll have the best chance in the world to
be killed. You just can't carry a gun to kill anyone yourself." So, Clark Poling left
his Pastorate in Schenectady, New York, and enlisted as a Chaplain. Just before
he left for active duty, Clark asked his father to pray for him __"Not for my safe
return that wouldn't be fair. Just pray that I shall do my duty ... and have the
strength, courage, and understanding of men. Just pray that I shall be
adequate." Poling began active duty on June 10, 1942 and served until February
3, 1943.

I light this candle in memory of Chaplain John P. Washington
John P. Washington grew up a poor, scrappy, and determined young man in the
toughest section of Newark, New Jersey. One of nine children born to an Irish
immigrant family, he was blessed with a sunny disposition, a beautiful singing
voice, and a love for music. He also loved a good fight, and was leader of the
South

Twelfth Street Gang when he was called to the Priesthood. He played ball with the boys of the Parish, organized sports teams and, when the war came along,

went with his "Boys" into the Army. He began active duty on May 9, 1942. His wonderful voice, raised in song and prayer to comfort those around him, could be heard until his final moments on February 3, 1943.

Meditation:

Today, we have heard tributes for friends, relatives, neighbors, Military personnel, and we are sad that they are not with us anymore, but aren't they? true, they have physically left our sacred circle, but their memories are till alive and well in our minds and hearts. Keep them close, and never forget their names.



The scholarship fund started at \$5.980.42 this year and 5 scholarships were approved in the spring. Fundraising and donations will be needed to continue this program. The committee voted to have a raffle for a \$100 gift card and a basket at State Grange session. Maine Agriculture in the Classroom has sponsored 1 scholarship annually and the Grange Store at Fryeburg Fair usually contributes. Last year at State session the raffle and donations raised \$375. 2022-23 Annual Report of the Maine State Grange Communications Director

Brothers and Sisters,

It is my distinct honor to report some activities and accomplishments from this year's efforts. This is the sixth full year I have served in the capacity of Communications Director—a position created in January 2014 that combined and expanded the historical roles of the publicity director and webmaster. My broad-based role includes assembling the printed Bulletin, maintaining the website, facilitating communication between and to State Leaders, advising on communication matters, and providing information and resources to Subordinate and Pomona Granges.

Ouring the past year, I published twelve monthly Bulletins without missing a deadline and wrote at least two columns each month. I am grateful to those directors and officers who regularly submit articles and support improving our internal communication.

The website is now in its thirteenth full year of operation in its current form. The objectives for the redesign in November 2010 were simple. Some of the more important included:

- To encourage prompt posting and maintenance of information and resources;
- To control that posting process with some level of moderation and quality control.
- To allow users to find pasic information and resources (such as applications, manuals, etc.) readily, and
- To arlow users to subscribe to the site and receive email versions of posts.

We continue to achieve those objectives. Site views have decreased by 3.0% over the previous year. There have been 20,840 site views from September 1, 2022, through August 31, 2023—an average of nearly 1,700 monthly. However, these visits do not include subscribers who are receiving the posts without necessarily visiting the site.

Considering the decline in Granges and Grange membership, the site is doing well. Some of that success can be attributed to the site design and content. The site is resource-rich and appeals to both members and non-members. The top pages visited are the information pages, such as the directory of Granges, program books, and information, etc. This year, however, several posts about Community Grange Events and programs received a lot of attention. This tells us how to maintain interest in the site.

Of course, numbers do not tell the entire story. Members and non-members continue to use the site as a vehicle for asking questions. These questions do not always appear on the site (unless they are of a general nature) but are handled by forwarding them to the appropriate party or parties.

During this past year, I have continued to add resource documents and tools to our collection of communication resources available on the site. There is value in our website.

Several significant accomplishments this year include.

- Added additional "Resources for Grangers" consisting of recorded interviews showing now successful Granges are doing so.
- Completed interviews with media representatives and researchery.
- Added an additional Site took® security feature to prevent "hacking" of the site. (This accounts for most of the increase over last year.)
- Completed a significant purge of the website significant posts and images. This makes the site
 much more manageable and saves server space.
- Continued to work with an editorial calendar to ensure regular, consistent posting.
- Continued to make "under the bood" improvements to the site.
- Continued posting of "special events" being sponsored or hosted by Granges. These events are also acced to the MSG Calendar Page.
- Continued to facilitate an email service that allows information to be sent directly to officers, directors, and deputies on short notice. This service also makes website subscriptions possible.

My goal is to keep costs associated with the website as low as possible by using "free" software versions and applying creativity to how things get done. Technology costs continue to rise as software companies look to change from purchased software to subscription software. Website security has become a growing issue requiring additional support and expertise.

Invoiced costs for the website almost totally reflect the expenses Abbot Village Press and I incur. I also apply the director's stipend to expenses. To give a complete picture, I include the stipend as part of the cost of the website and communication department to Maine State Grange and the membership. The past four years are shown in the table below.

I would encourage members to visit other state Grange websites and compare the appearance and content. Our site should be a source of pride! If we just use a conservative 21,000 site visits per year, each visit costs us less than eight cents. Currently, it costs sixty six cents just to mail a first-class letter. Those site visits cost less than eight cents each.

Thanks again to Heather and Phil Retberg of Halcyon Grange for their willingness to continue to share columns for our monthly "View from the Farm."

Looking ahead to 2023-2024, some objectives include:

Continuing to keep communication positive, helpful, and engaging.

- Investigate the feasibility of sponsoring at least one virtual roundtable discussion. This was not achieved last your due to time, imitations.
- Research further connections between the MSG website and social media.
- Continue searching for resources, including additional guest columnists and regular topical information that can be reposted with attribution.

Our greatest accomplishment is also our most significant need for the coming year. We must continue increasing participation and information, working to build a positive communication program. The Maine State Grange website is an integral part of our organization and is becoming a "go-to" place for members and friends who wish to learn more about our Order. We impact Maine Communities and beyond while preserving our heritage.

I believe the primary role of any state position or function is to support Subordinate and Pomona Granges and their members. But communication is not a "one-person job." Individuals, Community/Subordinate, and Pomona Granges can best support our communications efforts by providing positive news and information.

I will continue encouraging open communication throughout our Order and with the public. We must generate interest and excitement among our communities, prospective members, and ourselves.

Please let me know if there is anything I can do to help you and your Grange.
